He began by acknowledging that we all do our academic work on specific Indigenous, First nations, and Métis territories. Some of these territories are governed by treaties, but some are still unceded. He asked members to reflect on the conditions under which we occupy these spaces, today and always. For those attending this meeting in person, he acknowledged the meeting is being held on the traditional and unceded territory of the Algonquin Anishinaabeg People.

The Speaker and Deputy Speaker made several announcements concerning the operation of the meeting.

F. Application for Membership

PRESIDENT/MOUNT ROYAL: THAT the application of the Association of McGill Professors of Law for membership in CAUT be approved.

The delegate from the Association of McGill Professors of Law (AMPL) addressed Council delegates to express appreciation for approving the AMPL membership in CAUT and for the constant assistance and support from CAUT through their certification process.

04. Adoption of Minutes of Meeting of November 25-26, 2022

ANSUT/WATERLOO: THAT the minutes of the Council meeting of 25-26 November, 2022 be approved.

A. Business Arising

1) Motion re: Laurentian University

The Executive Director reported on follow-up that has been done following the motion passed at the November 2022 Council regarding Laurentian University. That motion called on CAUT to condemn the Government of Ontario and the Government of Canada for allowing the university to use the *Company Creditors Arrangement Act* to declare insolvency and drag the Laurentian University Faculty Association through a horrendous process that lead to significant job loss. One element of that motion asked CAUT to explore the possibility of setting up a fund for those tenured professors who were forced to retire or who lost their jobs in the process. He reported that a local group, the *April 12 committee distress fund*, has set up a GoFundMe website to launch a fundraising drive to assist those who are experiencing hardship. CAUT will issue a memo to member associations regarding the fund and encourage members to contribute.

The delegate from Laurentian, F. Colin, thanked CAUT for its support in looking at options for setting up a fund.

05. President's Remarks

The President welcomed delegates and guests to the 94th CAUT Council meeting.

He highlighted mobilization efforts over the past year through the convening of hybrid Council meetings, committee meetings, and conferences, as well as efforts to offer specialized training to build organizational capacity, including collective bargaining workshops, grievance training, and an equity conference. All of these efforts were done to strengthen the capacity of our member academic staff associations in their work. He highlighted the work CAUT is doing on the international front through involvement with Education International (EI). He indicated that CAUT continues to follow-up on the Laurentian insolvency and highlighted lobbying efforts to press for necessary corrections to bankruptcy and insolvency law, the *Companies' Creditors Arrangement Act (CCAA)*.

Members of the roundtable included: Michael Arfken, President, University of Prince Edward Island Faculty Association (UPEIFA); Ashrafee Hossain, President, Memorial University of Newfoundland Faculty Association (MUNFA); Chantale Jeanrie, Vice-President, Syndicat des professeurs et professeures de l'Université Laval (SPUL); and Adango Miadonye, President, Cape Breton University Faculty Association (CBUFA).

08. Guest speaker

Sam Dunietz, Senior Policy and Program Analyst with the National Education Association (NEA), presented on the increase of legislative attacks in the U.S.

(Florida, Texas and other states) that threaten tenure, collegial governance, and academic freedom at post-secondary institutions in the U.S., and what the NEA and other unions are doing to push back against these threats.

09. Presentation of the CAUT Milner Memorial Award

The Milner Memorial Award was presented to the Censure UofT group of the University of Toronto. 10. Forum for Executive Committee Candidates

Candidates for positions on the CAUT Executive Committee addressed Council and answered questions from delegates.

11. Report of the Executive Director on Academic Freedom

A. Academic Freedom

1) Issues

a) China research partnerships

The Executive Director reported the federal government announced in February that "grant applications that involve conducting research in a sensitive research area will not be funded if any of the researchers working on the project are affiliated with a university, research institute or laboratory connected to military, national defence, or state security entities of foreign state actors that pose a risk to our national security". In March 2023 the government announced consultations on a foreign influence transparency registry. CAUT has met with government officials to ensure restrictions are narrowly applied, justified, and do not lead to racial profiling.

b) Classroom discussion

The Executive Director reported on cases of academics facing discipline arising from student complaints over comments or material discussed in the classroom.

c) Alberta

The Executive Director reported that the government of Alberta has added an enforcement mechanism to its free speech requirements on campuses.

d) Academic Freedom and the Law

The Executive Director reported that the papers from the Harry Crowe Foundation Conference, held February 10-11, 2022, will be published in a special issue of the Canadian Employment and Labour Law Journal.

2) Cases

a) Simon Fraser University

The Executive Director reported on concerns raised by the Simon Fraser University Faculty Association (SFUFA) with the interference by the Administration with the independence of its Research Ethics Board (REB). Due to pressure from SFUFA and CAUT, as well as a petition within the university, the Administration has reversed its decision.

b) Cape Breton University

The Executive Director reported that CAUT intervened after the University of Toronto Press' decided to conduct a review of an article and that raised academic freedom concerns. He reported that the matter has been resolved and the article will not be retracted.

c) University of New Brunswick

The Executive Director reported on a controversy involving a PhD thesis at the University of New Brunswick.

B. Litigation

The Executive Director provided an update on the case of Hassan Diab.

1) CAUT arbitration service

a) Mount Royal University (Widdowson)

The Executive Director provided an update on the dismissal case of Professor Frances Widdowson at Mount Royal University.

b) Bishop's University (Stonebanks)

The Executive Director provided an update on the dismissal case of Dr. Christopher Darius Stonebanks at Bishop's University.

c) University of Toronto

The Executive Director updated on the group grievance around the Azarova case at the University of Toronto.

The Executive Director reported on an arbitration decision at Toronto Metropolitan University involving academic freedom and social media.

The Executive Director reported on a preliminary ruling at Humber College concerning the admissibility of expert evidence in an arbitration case involving academic freedom.

The Executive Director summarized a judicial review decision concerning the exclusion of faculty from certain portions of Board meetings.

The Executive Director reported on the judicial review concerning the Dalkir grievance.

 - to receive statements, instruments, agreements, terms and conditions, amendments to agreements and terms and conditions, and other documents, notices and communications with respect to the account(s) with the Financial Institution; and,
 - d) to settle the account(s) of the organization with the Financial Institution. Authorized Individuals are:
 - CAUT President
 - CAUT Vice-President
 - CAUT Treasurer
 - David Robinson, Executive Director
 - Tony Cantin, Director of Finance, Human Resources and Operations

- 3. The Financial Institution is entitled to rely on this resolution as duly and validly authorized and binding on the Organization. The Financial Institution is further entitled to rely on the authority of the Authorized Individuals to bind the Organization. The Financial Institution does not need to make any further inquiry into the authority of the undersigned, the authority of the Authorized Individuals and the validity of this resolution all of which will be enforceable against the Organization and may be acted upon by the Financial Institution.
- 4. There are no provisions in the constating documents, by-laws or any other resolution, agreement or document to which the Organization is bound which are inconsistent with this resolution. The Financial Institution is entitled to continue to rely on this resolution and the authority of the Authorized Individuals until the Financial Institution receives a valid resolution of the organization amending or rescinding this resolution.
