Opening Remarks and Territorial Acknowledgement

The President welcomed members to the 278th CAUT Executive Committee Meeting. He acknowledged this meeting is being held on the traditional and unceded territory of the Abenaki people and the Wabenaki confederacy, and of the Algonquin Anishinaabeg People.

01. Overview of Policy and Planning Agenda

The President provided an overview of the policy and planning session.

02. Report of the President

The President reported on his activities since the April Executive Committee and Council meetings. He attended the CUFA-BC Council on May 1-2 in Victoria. He also spoke at a symposium in Regina on May 4-6 with the Presidents of the Canadian Institutes of Health Research (CIHR), the Natural Sciences and Engineering Research Council (NSERC), the Social Sciences and Humanities Research Council (SSHRC), and Universities Canada. He also attended the *CAUT Forum for New Presidents* in Ottawa on June 9-10, and took part virtually in several member association events including: the University of Toronto Faculty Association (UTFA) AGM on April 25; the Brandon University Faculty Association (BUFA) AGM on April 25; the Queen's University Faculty Association (QUFA) on April 27; the Brescia Faculty Association (BFA) AGM on May 11, the Federation of New Brunswick Faculty Associations (FNBFA) on May 11; the Mount Royal Faculty Association (MRFA) AGM on May 12; the Dalhousie Faculty Association (DFA) AGM on May 17; and the University of Manitoba Faculty Association (UMFA) AGM on May 24.

T. Cantin, Director of Finance, HR and Operations, provided an overview of the various funds, charities and foundations that are managed by CAUT. He reported that each of these entities require significant administrative and financial time and resources. Upon discussion with legal counsel, CAUT management is recommending amalgamating its four related charities – the Harry Crowe Foundation, the CAUT Civil Liberties Defence Fund, the CAUT Refugee Foundation, and the J.H. Stewart Reid Fellowship Memorial Trust -- into one single charity that would operate under the name of "CAUT Foundation".

The Executive considered several questions: Is the Bulletin content engaging? Does it provide a different and helpful perspective? Are there opportunities for data collection with a digital opt-in? Should we look at changing the frequency of publication? Are there new opportunities to explore – such as digital ad revenue and video and multi-media content?

J. De Jaegher provided a status update on the development of a new CAUT website.

3) CAUT Journal

R. Whitaker, Chair of the CAUT Editorial Board, reported on the status of the *CAUT Journal*. A special issue focused on librarians and archivists, edited by Jennifer Dekker (University of Ottawa), is being planned.

1) Academic freedom and national security

The Executive Director reported that the federal government is considering establishing a <u>Foreign Influence Transparency Registry</u> (FITR) that could affect academic staff. CAUT participated in consultations on the proposed FITR and raised several concerns.

2) Academic freedom and equity statements

The Executive Director reported that a sub-group of the Executive Committee (A. Hearn, S. Spronk, M. Claybourn, and S. Chau) has drafted an advisory on academic freedom and equity statements to guide associations on the practice of institutions requiring job candidates to provide an EDI statement as part of their application process. Further feedback will be solicited from the Academic Freedom and Tenure Committee and the Equity Committee.

3) Florida

The Executive Director shared the preliminary report of the American Association of University Professors' (AAUP) Special Committee on Academic Freedom and Florida. The report concludes: 'that academic freedom, tenure, and shared governance in Florida's public colleges and universities currently face a politically and ideologically driven assault unparalleled in US history.' He highlighted recent tenure denials at the New College of Florida.
