The Speaker called the meeting to order and welcomed delegates and guests to the 96th CAUT Council meeting.

He began by acknowledging that we all do our academic work on specific Indigenous, First nations, and Métis territories. Some of these territories are governed by treaties, but some are still unceded. He asked members to reflect on the conditions under which we occupy these spaces, today and always. For those attending the meeting in person, he acknowledged the meeting is being held on the traditional and unceded territory of the Algonquin Anishinaabeg People.

He made several announcements concerning the operation of the meeting.

The President welcomed delegates and guests to the 96th CAUT Council meeting. He highlighted that, following more than 18 months of negotiations, the Association of McGill Professors of Law (AMPL) is currently on strike to achieve a fair and equitable contract. He asked all those in attendance to take a moment to show solidarity with our colleagues at McGill University and call on the employer to reach a fair contract. He encouraged members to send a message to the President of McGill calling for a fair deal.

08. Presentation of the Sarah Shorten Award

The Sarah Shorten Award was presented to the Rupertsland Centre for Metis Research, at the University of Alberta.

09. Presentation of the Academic Librarians' and Archivists' Distinguished Service Award

The Academic Librarians' and Archivists' Distinguished Service Award was presented to Kathleen Scheaffer of the University of Toronto and Rumi Graham of the University of Lethbridge.

10. Forum for Executive Committee Candidates

Candidates for positions on the CAUT Executive Committee addressed Council and answered questions from delegates.

11. Report of the Executive Director

- A. State of the Sector
 - 1) University and College Finances

The Executive Director presented an overview of university and college finances.

B. Academic Freedom

- 1) Issues
 - Federal Policy on Sensitive Technology Research and Affiliations of Concern

The Executive Director reported on the Policy on Sensitive Technology Research and Affiliations of Concern (STRAC) released in January. As of May, the federal government will not fund research in "sensitive areas" and in partnership with specified foreign institutions linked to "hostile" state, military, or security services. The list of prohibited institutions

includes mostly Chinese entities.

b) Israel/Palestine

The Executive Director reported that CAUT continues to assist associations with cases related to the Israel/Palestine conflict. He highlighted concerns raised with the Canary Mission, a website that lists people and groups identified as being anti-Israel activists.

c) Academic Freedom and Departmental Speech

The Executive Director reported on the University of British Columbia's removal, in January, of the Anthropology Department's statement on Gaza from the University website. He announced that an agreement was reached between the University and the Faculty Association that led to the statement being re-posted. He noted the issue of academic freedom and departmental speech is being considered by the CAUT Academic Freedom and Tenure Committee.

d) Alberta Bill 18

The Executive Director reported on Alberta's new Bill 18, the *Provincial Priorities Act*, which would permit the province to approve any funding agreement between a federal entity and a provincial entity – including research funding for universities and colleges.

Member associations in Alberta have expressed serious concerns with the new legislation. CAUT has asked for a legal opinion on the potential impact of the legislation for the post-secondary education sector in the province.

EMERGENCY RESOLUTION

Confederation of Alberta Faculty Associations (CAFA)/Association of Academic Staff of the University of Alberta (AASUA):

WHEREAS the Government of Alberta Bill 18 proposes requiring provincial government approval before public institutions can accept federal funding in order to ensure the funding request aligns with "provincial priorities";

AND WHEREAS the Government of Alberta has specifically identified postsecondary institutions as a class of entities to whom Bill 18 applies;

AND WHEREAS this interference can fall particularly heavy on researchers from historically excluded communities;

AND WHEREAS government-imposed ideological tests are antithetical to the ethical practice of research;

BE IT RESOLVED THAT CAUT condemns Alberta's proposed Bill 18 "the *Provincial Priorities Act*," as a dangerous attack on university

autonomy, academic freedom, and the ethical practice of research.

2) Cases

a) Langara College

The Executive Director reported on the case of Dr. Natalie Knight at Langara College.

b) Institut national de la recherche scientifique

The Executive Director reported on the Government of Quebec's refusal to ratify the appointment of Professor Denise Helly to the Board of the *Institut national de la recherche scientifique* (INRS). Dr. Helly specializes in minority rights, Islamophobia and hate speech. The case raises the issue of institutional autonomy and political interference.

c) Université Laval

The Executive Director reported on the case of Professor Patrick Provost (Université Laval). Professor Provost was disciplined for comments he made questioning the safety and efficacy of COVID-19 vaccines for children. His suspension was extended for participating in a media interview which the University claims violated his obligation to refrain from "professorial duties" during his suspension. Further discipline was imposed in April.

C. Legal

- 1) CAUT Arbitrations Service
 - a) Mount Royal University (Widdowson)

The Executive Director provided an update on the dismissal case of Professor Frances Widdowson from Mount Royal University. CAUT is acting as counsel through the CAUT Arbitration Service.

b) Bishop's University (Stonebanks)

The Executive Director provided an update on the dismissal case of Dr. Christopher Darius Stonebanks from Bishop's University.

The Executive Director reported that CAUT will also be providing legal support for a case involving discrimination, academic freedom, and collegial governance at the University of Ottawa's Institute of Indigenous Research and Studies.

- 2) Arbitration and Court Decisions
 - a) Li v. Canada (Citizenship and Immigration)

The Executive Director reported on a Federal Court decision in the case of *Li v. Canada* (*Citizenship and Immigration*), involving the denial of a visa to a Chinese graduate student. The Court upheld the denial based on a broadened definition of espionage. The Court accepted that while there was no evidence the student was trained as or is a spy, he could be potentially recruited to become one. The Court concluded that: "As hostile state actors increasingly make use of non-traditional methods to obtain sensitive information in Canada or abroad, contrary to Canada's interests, the Court's appreciation of what constitutes 'espionage' must evolve."

A. Resolution from the Syndicat des professeurs de l'Université Laval (SPUL)

MOVED: SYNDICAT DES PROFESSEURS ET PROFESSEURES DE L'UNIVERSITÉ LAVAL SECONDED: SYNDICAT GÉNÉRAL DES PROFESSEURES ET PROFESSEURS DE L'UNIVERSITÉ DE MONTRÉAL

WHEREAS the 2023-2027 collective agreement between Université Laval and the Syndicat des professeurs et professeures de l'Université Laval (SPUL) came into effect on May 24, 2023;

WHEREAS clause 1.3.04 stipulates that "The Employer recognizes that the By-Laws cannot be in contradiction with the collective agreement" and that "Should this be the case, [the Employer] is responsible for making the necessary amendments to the By-Laws.";

WHEREAS clause 1.3.02 stipulates that "collegiality is a fundamental principle of university life," that "teaching faculty members are at the heart of the university's governance and participate democratically in decisions that affect

what the University should be, both in the present and in the future," and that "transparency is an essential component of collegiality";

WHEREAS Université Laval has begun a process of revising its By-Laws;

CAUT supports SPUL in its demands that the Université Laval By-Law revisions be conducted such that the By-Laws are compatible with the collective agreement, including by integrating the principles of collegiality and transparency, and reforming the electoral college so that teaching faculty can democratically participate in electing the rector.

CARRIED UNANIMOUSLY

B. Resolution from the York University Faculty Association (YUFA)

MOVED: YORK UNIVERSITY FACULTY ASSOCIATION SECONDED: UNIVERSITY OF TORONTO FACULTY ASSOCIATION

WHEREAS CAUT supports and defends Academic Freedom;

AND WHEREAS CAUT has a policy with respect to Academic Staff and Criminal Conviction stating an "academic staff member charged with a criminal offence but not incarcerated shall continue to carry out the duties associated with their position in the normal manner, receiving full pay and benefits. Suspension of the member is only justified where their presence on campus poses a clear, serious and imminent danger to any member of the academic institution."

AND WHEREAS York University placed Professor Wood on an indefinite "leave" in response to charges brought forward by the Toronto Police Services against Professor Wood for her alleged participation in a protest action supporting a long-standing campaign against the HESEG Foundation for Lone Soldiers and, more urgently and broadly, opposing the Israel Defence Forces' ongoing military campaign in Gaza;

AND WHEREAS political protest and other means of free expression are protected by the Canadian Charter of Rights and Freedoms, and due process includes the core judicial principle of the presumption of innocence;

THEREFORE BE IT RESOLVED THAT CAUT issue a statement, similar to YUFA's statement, calling for the immediate reinstatement of Professor Wood.

BE IT FURTHER RESOLVED THAT CAUT'S Executive Director convey CAUT'S call for the reinstatement of Prof. Wood to Rhonda Lenton (President, York University), Lisa Philipps (Provost), Paul Tsaparis (Chair, Board of Governors, c/o Pascal Robichaud, University Secretary) JJ McMurtry (Dean, Faculty of Liberal Arts and Professional Studies), with copy to Mark Thomas (Chair, Department of Sociology, York University).

C. Resolution from the Saint Mary's University Faculty Union (SMUFU)

MOVED: SAINT MARY'S UNIVERSITY FACULTY UNION

SECONDED: MOUNT SAINT VINCENT UNIVERSITY FACULTY ASSOCIATION

GIVEN THAT the senior administration of Saint Mary's University has indicated the existence of urgent financial circumstances that if unaltered may threaten the future viability of Saint Mary's University, and

GIVEN THAT the senior administration has undertaken and proposed austerity measures outside the bounds of the Collective Agreement Between Saint Mary's University and the Saint Mary's University Faculty Union, without engaging academic staff in meaningful consultation, rejecting all calls for financial accountability, collegial governance and transparency of process, and

GIVEN THAT on April 9, 2024, 91.1% of responding members of SMUFU (85%) voted in favour of a motion of non-confidence in the leadership of Saint Mary's University President and the Chair of the Board of Governors, and

GIVEN THAT the Board of Governors of Saint Mary's University has not responded in any way to this expression of nonconfidence and continues to ignore the Union's calls for accountability, transparency, and meaningful consultation,

BE IT RESOLVED THAT the Canadian Association of University Teachers formally endorse the vote of non-confidence in the leadership of Saint Mary's University President, Robert Summerby-Murray and the Chair of the Board of Governors, Alan Abraham, passed by Saint Mary's University Faculty Union, on April 9, 2024.

CARRIED UNANIMOUSLY

D. Resolution from the Mount Allison Faculty Association (MAFA)

MOVED: Mount Allison Faculty Association SECONDED: University of Winnipeg Faculty Association

WHEREAS the imminent threat of an incursion into Rafah and the significant barriers that continue to exist for people trying to leave Gaza meet the criteria for a CAUT Council emergency resolution.

WHEREAS CAUT By-Law Number 1 identifies several core CAUT functions including the defence of academic freedom and the establishment and maintenance of international relations with Academic staff in other countries (s. 2.2).

WHEREAS CAUT identifies one of its core values as *promoting civil liberties*, recognizes that academic freedom rests upon a broader foundation of freedom of expressions and respect for civil liberties, and is committed to protecting and expanding human rights and civil liberties in Canada and beyond.

WHEREAS on November 2019, the *CAUT Social Justice Policy Statement* was approved by CAUT Council and reads:

CAUT is committed to social justice as a dynamic goal of all societies. Social justice includes, but is not limited to, respect for the human rights, democratic rights, Indigenous and treaty rights, civil liberties, and sexual and reproductive rights of all individuals, without discrimination. It includes

climate justice, and equitable treatment under the law and equitable access to adequate essentials of daily living, health care, education, and other public services, as well as to meaningful work. All individuals, groups and institutions have an obligation to promote social justice. The absence of social justice both in Canada and around the world undermines the ability of university and college academic staff to fulfil effectively their public obligation to teach, research and disseminate knowledge.

WHEREAS on November 22, 2023, CAUT issued a public statement on academic freedom in times of conflict which recognizes that "it is during times when political threats to academic freedom intensify, that the need for academic staff to contribute to public discourse becomes even more important" and that "if institutions fail to defend academics from illegal harassment or true threats, they violate their obligation to uphold academic freedom."

WHEREAS the systematic destruction of the post-secondary education system in Gaza is not only a clear threat to academic freedom, it also undermines the ability of Palestinian academic staff to fulfill effectively their public obligation to teach, research, and disseminate knowledge.

WHEREAS on October 20, 2023, the General Council of the International Trade Union Confederation (ITUC) – the largest trade union federation in the world – called for a ceasefire by all parties and the return of all hostages and people held in Gaza and Israel without legitimate legal basis to their homes.

WHEREAS in November 2023, Education International (EI) – representing 32 million teachers in 178 countries who are part of 383 member organizations including the General Union of Palestinian Teachers (GUPT) and the Palestinian Federation of Unions of University Professors and Employees (PFUPPE) - called on the international community to push for the implementation of a humanitarian ceasefire to stop the killing of students, teachers, and all civilians in Gaza.

WHEREAS in January 2024, the Canadian Labour Congress (CLC) Executive Committee voted unanimously to support the International Trade Union Confederation (ITUC)'s call for an immediate ceasefire.

WHEREAS on February 14, 2024 the American Association of University Teachers (AAUP) joined the labour movement's call for an immediate ceasefire and end to the siege of Gaza.

BE IT RESOLVED THAT CAUT calls for an immediate and permanent ceasefire between Israel and Hamas.

BE IT RESOLVED THAT CAUT calls for the immediate and unconditional release of all hostages and detainees unlawfully held in Gaza and Israel and for both parties to adhere to standards of international law and Geneva Convention rules of warfare concerning the welfare and security of civilians.

BE IT RESOLVED THAT CAUT calls for access to adequate essentials of daily living, health care, education, and other public services to be immediately restored in Gaza and that foreign nationals and Palestinians requiring medical care be allowed to leave Gaza.

BE IT RESOLVED THAT the CAUT Executive Committee will take all reasonable steps to support academics and their families displaced by this conflict.

The Financial Institution does not need to make any further inquiry into the authority of the undersigned, the authority of the Authorized Individuals and the validity of this resolution all of which will be enforceable against the Organization and may be acted upon by the Financial Institution.
- 4. There are no provisions in the constating documents, by-laws or any other resolution, agreement or document to which the Organization is bound which are inconsistent with this resolution. The Financial Institution is entitled to continue to rely on this resolution and the authority of the Authorized Individuals until the Financial Institution receives a valid resolution of the organization amending or rescinding this resolution.

19. Legal Services and Labour Relations Report

- A. Collective Bargaining
 - S. Godwin, Director of Labour Relations Services and General Counsel, reported on the status of collective bargaining across the country.
- B. Research
 - S. Godwin noted that the research department continues to update the CAUT Collective Bargaining Dashboard available on the CAUT website. Updated university financial data (2021/2022), university salary data (2022/2023 UCASS), and enrolment data is now available on the members' only section of the website. The Librarian and Archivist Salary Survey (LASS) is nearing completion, and staff are supporting the Aboriginal Post-Secondary Education Working Group (APSEWG) on a national survey for Aboriginal academic staff.

C. Legal

S. Godwin, Director of Labour Relations Services and General Counsel, provided an update on the case of Frances Widdowson at Mount Royal University. Widdowson is a tenured professor dismissed on December 20, 2021, for satirical twitter commentary and for filing allegedly frivolous harassment complaints. Academic freedom and what constitutes harassment are key issues. Testimony

was completed November 16, 2023, with submissions finished by January 24, 2024. We are awaiting a decision.

She provided an update on the case of Christopher Darius Stonebanks at Bishop's University. Stonebanks is a tenured professor dismissed on November 16, 2021, for allegedly being too vociferous in his claims of racism within the university. Unconscious bias and academic freedom are both at issue. Several hearing dates have been set from now until December 2025.

The legal team has been providing summary advice on a range of issues including the duty to accommodate; employer investigations; bargaining unit integrity; collegial governance; and bad faith bargaining.

20. Political Action and Communications Report

A. Political Advocacy

I. Cockburn, Acting Director of Political Action and Communications, reported that CCAA amendments have passed $2^{\rm nd}$ reading in the House. He also reported on Budget 2024 highlights that included \$1.8 billion over five years to core research grant funding for CIHR, NSERC and SSHRC. There is also an increased annual value of master's and doctoral student scholarships to \$27,000 and \$40,000 respectively, and post-doctoral fellowships to \$70,000 – totaling \$825 million over five years.

He reported that CAUT is closely following the federal government's announcement in January of a cap for processing international student permits as well as the new Federal government Policy on Sensitive Technology Research and Affiliations of Concern released in early 2024.

B. Campaigns and Organizing

I. Cockburn reported on plans for preparing a Federal Election campaign that will include tools and resources for members, a platform for communications with parties and candidates, and a public advocacy campaign.

C. Communications

 - I. Cockburn provided an update on the CAUT Bulletin.

2) CAUT Journal

R. Whitaker, Chair of the Editorial Board, provided an update on the activities of the CAUT Journal. She reported on an upcoming special issue, *The labour activism of post-secondary education information workers*, edited by Jennifer Dekker (University of Ottawa). Submissions are through the peer review process and are being finalized for publication.

She reported on a new special edition, *Shaping Equity as Labour Justice:* successes, stumbles and setbacks, that will be edited by Dr. Alison Hearn (Western University) and Dr. Momin Rahman (Trent University).

Past President, B. Austin-Smith, reported on nominations received for the positions of Speaker, Deputy Speaker, and Elections and Resolutions Committee members.

A. UN Special Rapporteur on Education: Academic Freedom and Freedom of Expression in Educational Institutions

The Executive Director reported that the United Nations (UN) Special Rapporteur on Education is preparing a report to the UN that will focus on "academic freedom and freedom of expression in educational institutions". CAUT has participated in two expert roundtable discussions focusing on threats to academic freedom arising from government interference, corporate influence over research, and precarious employment contracts. The final report is expected to be delivered in June.

B. UN High Level Panel on the Teaching Profession

The Executive Director reported that the United Nations High Level Panel on the Teaching Profession released its report in January. The report contains 59 recommendations focusing on: improving pay, conditions, and employment security; collective bargaining and the right to strike; equity and diversity; professional autonomy and academic freedom; and better public funding.

C. OECD Study of Academic Careers

The Executive Director reported on the OECD's comparative analysis of academic

careers. The report highlights the concerns about working conditions of academic staff, including the increased reliance on precarious and casual contracts, high workloads, and negative impacts on work-life balance.

D. International Solidarity

The Executive Director reported on continued international solidarity collaboration with the College and Lecturer's Association of Zimbabwe (COLAZ); the University Academic Staff Union in Kenya (UASU Kenya), and Scholars at Risk (SAR).

E. Education International

The Executive Director reported that the 10th Education International (EI) World Congress will be held July 29 to August 2, 2024, in Buenos Aires, Argentina. CAUT, the American Federation of Teachers (AFT), and the University and College Union (UCU) are proposing a resolution on academic freedom.
