## **Opening Remarks and Territorial Acknowledgement**

The President welcomed members to the 285<sup>th</sup> CAUT Executive Committee meeting. He acknowledged the meeting is being held on the traditional and unceded territory of the Algonquin Anishinaabeg People.

### **02.** Approval of Executive Committee Minutes

A. Meeting of September 27-28, 2024

**SCHROEDER/SPRONK: THAT** the minutes of the Executive Committee meeting of September 27-28, 2024, be approved.

A. Review of Action List

The action list was reviewed.

## 04. Report of the President

The President reported on his activities since the September Executive Committee meeting. He noted that the Association of McGill Professors of Law (AMPL) reached an agreement after a 15-week strike. He added that several academic units at McGill University are in the process of certification. He reported that the Syndicat des professeures et professeurs de l'Université de Sherbrooke (SPPUS) will be admitted formally into CAUT at this Council meeting broadening our membership.

On Federal lobbying, he highlighted CAUT's submission in October to the Standing Committee on Science and Research's study on the new Capstone Research Funding Organization which would effectively replace the three granting agencies. CAUT has expressed doubts about the need to amalgamate the granting councils and is recommending the new agency uphold the principles of investigator-led research and ensure more funding for basic research.

He and other members of the Executive Committee attended several annual general meetings of CAUT member associations including the University of Northern British Columbia Faculty Association (UNBCFA) on October 28, in Prince George; the Memorial University of Newfoundland Faculty Association (MUNFA) on October 28, in St. John's; the Association of Academic Staff at the University of Alberta (AASUA) on November 20, in Edmonton; and the Faculty Union of the Nova Scotia College of Art and Design (FUNSCAD) on November 20, in Halifax.

He and the Executive Director will attend the Saint Mary's University Faculty Union's (SMUFU) 50<sup>th</sup> anniversary next week.

He reported on the CAUT Aboriginal Academic Staff conference: *Translating Indigenization of the Academy into Practice,* which was held in Regina, Saskatchewan, October 4-5, 2024, noting it was a very successful conference with a great keynote address and well received plenary sessions.

The Executive Director reported on the implementation of the new policy on Sensitive Technology Research and Affiliations of Concern (STRAC). CAUT is collaborating in the Chinese Canadian Faculty Project – an initiative through the Simon Fraser Labour Studies Program and the Simon Fraser University Morgan Centre for Labour Research – to collect views and experiences regarding academic freedom, racial profiling and open international research.

3) Langara College (Knight)

The Executive Director provided an update on the dismissal of Dr. Natalie Knight from Langara College.

## 4) Dalhousie

The Executive Director reported on a case at Dalhousie University involving an access to information request for records with information related to "Gaza" "Israel" "Palestine" and "IDF". The Administration's privacy officer is asserting the records are in the custody and control of the University and should be produced.

The Executive Director reported on the decision in *University of Calgary v. AIPC 2024 ABKB 522,* an appeal of a freedom of information request for academic staff records.

5) University of British Columbia

The Executive Director reported on two academic freedom cases at the University of British Columbia (UBC).

The Executive Director provided an update on the case of Dr. Christopher Darius Stonebanks at Bishop's University.

The Executive Director provided an update on a case involving alleged systemic discrimination at the University of Ottawa's Institute of Indigenous Research and Studies (IIRS).

The special edition, *Shaping Equity as Labour Justice: successes, stumbles and setbacks,* edited by Dr. Alison Hearn (Western University) and Dr. Momin Rahman (Trent University), is in the review stage and is expected to be completed this Winter.

The committee is also in the early planning stages of the Collective Bargaining and Organizing Forum which will be held in March 2025. They are also working on developing a policy statement on artificial intelligence.

3) Contract Academic Staff

N. Papatheodorakos, Chair of the Contract Academic Staff Committee, reported that the committee is developing a policy statement on collegial governance and artificial intelligence. He reported on *Fair Employment Week* held October 21-25.

4) Equity

S. Spronk, Co-Chair of the Equity Committee, reported that the committee is hosting new monthly 'National Equity' zoom sessions to highlight key equity issues.

5) Librarians' and Archivists'

J. Dekker, Chair of the Librarians' and Archivists' Committee, reported that the committee is in the process of defining the theme and panels of the CAUT Librarians' and Archivists' Conference, scheduled for October 3-4, 2025. The committee is also holding a cross-country virtual listening tour this Fall and Winter which will involve conducting interviews with librarians and archivists to identify key issues facing the profession.

The committee's workplan includes reviewing the CAUT Collective Agreement Database for articles related to governance issues; exploring options for developing training on governance; collecting suggestions for materials to include in the governance library; and developing a protocol for approval of materials to add to the library.

D. Newhouse, Chair of the Aboriginal Post-Secondary Education Working Group (APSEWG), reported on the CAUT Aboriginal Academic Staff Conference, *Beyond Words: Translating Indigenization of the Academy into Practice,* held October 4-5, in Regina.

The working group launched a survey on experiences of Indigenous academic staff in conjunction with the conference. The survey aims to understand Indigenous academic staff members' academic pathways and experiences on campuses across Canada. The committee also reviewed the revised *Bargaining Advisory on Indigenization of the Academy*, which should be released soon.
